CONDITION FOR ENTRY OF BIRDS

THIS SHOW IS HELD IN STRICT ACCORDANCE WITH THE TERMS AND CONDITIONS OF THE LICENCE AUTHORISED BY THE SECRETARY OF STATE 2006.

THIS LICENCE PERMITS THE COLLECTION OF BIRDS AT FAIRS, MARKETS, SHOW EXHIBITIONS AND OTHER GATHERINGS SUBJECT TO THE CONDITIONS SET OUT IN THE SCHEDULE.

GENERAL LICENCE CONDITIONS

- 1. A RECORD OF ALL EXHIBITORS AND VENDORS WILL BE KEPT FOR 3 MONTHS, AND IS TO INCLUDE THE FULL NAME, HOME ADDRESS AND TELEPHONE NUMBER, PLUS THE NUMBER AND TYPES OF BIRDS. (ALL AS DETAILED ON ENTRY FORM)**
- 2. ENTRY CANNOT BE ALLOWED BY ANY BIRDS BROUGHT INTO UK FROM ANY OTHER EU COUNTRY IN THE PREVIOUS 4 WEEKS.**
- 3. THERE IS AN EU WIDE BAN ON IMPORTS OF LIVE BIRDS FROM THIRD WORLD COUNTRIES ALREADY IN PLACE.**
- 4. THERE IS A VETERINARY SURGEON ON CALL IF REQUIRED.**
- 5. BIO-SECURITY INFORMATION WILL BE AVAILABLE.**
- 6. SALES OF BIRDS THROUGH SALES CLASSES OR SALES TABLES IS PERMITTED SUBJECT TO THE CONDITIONS IN PARAGRAPH 2 ABOVE.**
- 7. SALES TRANSFER FORMS WILL BE AVAILABLE FROM SHOW SECRETARY AND MUST BE COMPLETED AND HANDED INTO THE DOOR STEWARD AS A PASS OUT FOR BROUGHT BIRDS.**
- 8. THE SALE OF BIRDS IS NOT PERMITTED FROM OUTSIDE SHOW HALL WITH NO TRADING FROM CARS IN CAR PARK.**

THESE CANNOT BE ACCEPTED UNLESS THE REQUIRED INFORMATION IS COMPLETED FOR BOTH SELLER AND BUYER.

THESE RECORDS WILL BE DESTROYED AFTER THE REQUIRED PERIOD OF 3 MONTHS.

BIO- SECURITY CONDITIONS

ALL CAGES AND CARRY BOXES MUST BE CLEANSED AND DISINFECTED BEFORE THE SHOW AND SHOULD BE REPEATED ON THE RETURN HOME AND BEFORE THE USE WITH ANY OTHER BIRD.

BIRDS PURCHASED AT THE SHOW MUST BE ISOLATED FOR AT LEAST 7 DAYS FROM OTHER BIRDS. ANY SIGNS OF ILL HEALTH OBSERVED IN THE PURCHASED BIRDS DURING THIS PERIOD OF TIME MUST BE REPORTED TO A VETERINARY SURGEON AND NOT MIXED WITH ANY OTHER BIRDS UNTIL THE PRESENCE OF AN AVIAN DISEASE HAS BEEN RULED OUT.

DATA PROTECTION

BIRD SALES

THE SALE OF BIRDS IN CAR PARK IS STRICTLY FORBIDDEN

ALL BIRDS SOLD MUST BE RECORDED ON A RECORD OF MOVEMENT FORM, OBTAINABLE FROM SHOW SECRETARY.

THIS MUST BE RETURNED TO SHOW SECRETARY WHO WILL KEEP FOR 3 MONTHS AND THEN DESTROYED.

THE ABOVE PROCEDURE ALSO APPLIES FOR ANY PRE-ORDERED BIRDS BROUGHT TO THE SHOW FOR COLLECTION.

SHOW RULES

- 1 C.C.B.A. SHOW RULES APPLY
- 2 EXHIBITS TO ARRIVE AT SHOW HALL BY 8.45 AM ON 18 OCT 2025 (SHOW HALL OPENS AT 7.45 AM)
- 3 JUDGING STARTS AT 9.15AM
- 4 ANY EXHIBITOR REGISTERING A PROTEST MUST DEPOSIT A SUM OF £10.00 WITH SHOW MANAGER, WHICH WILL BE RETURNED IF THE PROTEST IS UPHOLD.
- 5 NO BIRD CAN BE REMOVED FROM ITS SHOW CAGE UNLESS AUTHORISED BY SHOW MANAGER.
- 6 THE SHOW COMMITTEE WILL TAKE ALL REASONABLE PRECAUTIONS TO ENSURE THE SAFETY OF EXHIBIT WHILST IN THEIR POSSESSION. NO RESPONSIBILITY CAN BE TAKEN FOR LOSS OR DAMAGE OF EXHIBITS, CAGES OR EQUIPMENT. HOWEVER, THE SHOW COMMITTEE WISH TO ASSURE EXHIBITORS THAT THE EXHIBITS WILL BE GIVEN PROPER CARE DURING THE SHOW.
- 7 ONLY D DRINKERS AND C.C.B.A. BLACK TUBULAR DRINKERS TO BE USED ON CAGES UNTIL ALL JUDGING IS COMPLETE. EXHIBITORS WILL THEN BE PERMITTED TO PUT ON AND BE RESPONSIBLE FOR ANY ADDITIONAL DRINKERS PLACED ON THE CAGE.
